The publication of articles does not depend on their oral presentation.

4. TARGET AUDIENCE

You can submit articles:

- Professors linked to undergraduate and/or postgraduate courses (both Lato Sensu specialization and Stricto Sensu in the Master's and Doctorate lines) who are interested in showing their unpublished scientific studies on one of the proposed thematic areas.
- Specialists, Masters, PhDs, Researchers, University Professors.
- Judges, Representatives of the Public Prosecutor's Office, Lawyers and other legal professionals and, in general, people who dedicate themselves in their professional field, to any branches or disciplines of Law, who are interested in showing their unpublished scientific studies on any of the areas proposed themes.
- Stricto Sensu Postgraduate Students (master's and doctoral students).
- Lato Sensu Postgraduate Students (specializing and specialists).
- Undergraduate students can submit their articles as long as they are co-authored with their advisor (with the possibility of publication only in the CONSINTER book).

The main criterion for publication in the *CONSINTER International Journal of Law - QUALIS A3* is the author having a Ph.D. title. If he does not have it, his article will be evaluated in the same way, and if approved by the *CONSINTER* Council, it shall be published in the book Direito e Justiça.

Observing CONSINTER's basic premise of supporting and promoting scientific and academic production, it is important to inform that all articles proven to be registered, paid and originated in accordance with the target audience described above in item 4 and in accordance with the submission rules indicated in item 16 of this document.

5. DISSEMINATION OF THE LEGAL INVESTIGATION AND PUBLICATION OF THE ARTICLES

Observing the scenario that imposes great difficulties for those interested in publishing their studies and research work, CONSINTER appears with the purpose of contributing to the dissemination of academic studies, publishing them, facilitating their dissemination, and also promoting excellent research training and the knowledge transfer from the University to society.

The articles will be subjected to a selection and approval process by the Editorial Board of *CONSINTER*, meeting criteria of scientific quality, being the analysis carried out in the double-blinded review system, according to the requirements by the national and international institutions and agencies of investigation and teaching that evaluate the investigating activity of post-graduation.





Thus, in addition to providing visibility to scientific production in official *CONSINTER* publications, the authors of the approved articles by the *CONSINTER* Editorial Board shall have:

- a) His/her paper published in the *CONSINTER* International Law Journal *QUALIS A3* and indexed in the National and International databases of great relevance in the academic world, allowing greater visibility for it, such as *Scielo Portugal*, *Dialnet Google Scholar*, *Latindex*, *REDIB*, *CAPES*, *LivRe*, *Sumários.org*, *Cite Factor*, *Superior Electoral Court*, *Virtual Network of Integrated Libraries* (*RVBI*), *MIAR*, *MIGUILIM*, *Diadorim* and member *of Crossref* or in the book Law and Justice.
- b) The opportunity to present your scientific article orally during CONSINTER Universidad Complutense de Madrid 2024, upon payment of an additional fee for participation/oral presentation of the article at the event, which must be done at the time of registration (see item 13).
- c) The possibility of receiving international certification if you choose to participate in the event.
- d) The opportunity to spread your scientific study, reaching internationally a larger number of people.
- e) The possibility of expanding your network with people of high scientific and academic levels.
- f) The opportunity to seek the transfer of scientific knowledge, which will contribute to the recognition of research activity and international scientific cooperation.

6. INFORMATION

All texts will be evaluated by the double-blind review system, respecting the authors' anonymity.

At the sovereign and exclusive discretion of the CONSINTER Editorial Board, some texts will be selected for publication in the CONSINTER International Journal of Law - QUALIS A3, with the respective ISSN. This publication will have two editions in Portugal, one printed and the other digital, which is available free of charge.

The selection of the article for publication takes into account numerous factors, from the chronological order of the date of receipt, the date of return after making corrections when requested, among other criteria.

The publication date of the article is NOT linked to the date of the call notice, nor the date of the event, and may be published after the event.

The articles that have not been selected to the journal "Revista Internacional CONSINTER de Direito - QUALIS A3", but which have been approved by the Editorial Board, will be published in the official book of "CONSINTER Direito e Justiça", with ISBN register. This publication will have three editions: one printed in Portugal, and two editions in Brazil (one digital and the other one printed).





Approved articles may be presented orally during the CONSINTER International Law Symposium of the current year, by the author(s), with a set time that will be informed by email.

7. DEADLINES

The article can only be sent via upload on the website https://revistaconsinter.com/index.php/ojs/about/submissions according to the instructions below and/or stated there after registration and payment is made. The article must only be uploaded once on the website mentioned above by one of the authors. https://docs.pkp.sfu.ca/learning-ojs/3.3/en/authoring#submitting-an-article to check out the step-by-step guide on how to submit the article.

8. NOTIFICATION OF APPROVAL

The decision by the CONSINTER Editorial Board on the approval or rejection of the articles submitted will be reported directly to the author by e-mail.

9. REQUIREMENTS

- a) The submission of the scientific paper for analysis is subject to confirmation of registration and payment, at the same time, of all authors and co-authors.
- **b**) Only articles approved by the CONSINTER Editorial Board will be published.

10. ORAL PRESENTATION

All articles duly registered, paid, and approved, according to item 13, may be presented at the XI CONSINTER Symposium as long as they have been purchased in the following options:

- a) COMBO registration/submission of the article + participation/presentation.
- b) Acquisition of Additional for participation/presentation of the article (previously registered and approved) at the XI CONSINTER Symposium 2024.

11. DECLARATION OF ARTICLE ACCEPTANCE

The declaration of acceptance of the scientific article will be issued, as long as the article is approved by the CONSINTER, upon request to the e-mail <u>contact@consinter.org</u>.





12. REGISTRATION

- a) For payment in foreign currency, check trading day.

- c) The registration payment of the authors and co-authors is indispensable at the time of registration and will entitle the article to evaluation.
- **d)** Co-written articles will be accepted as long as they are properly subscribed, being allowed a maximum of 3 (three) co-authors by article.
- e) We inform that the CONSINTER does not refund payments made, even when the articles have not been accepted by the CONSINTER Editorial Board.
- f) The difference in the registration fee will be charged if it is made on a date and the article is sent at a later date.
- g) There will be an additional fee for participation/presentation of the article during the XI Symposium of CONSINTER 2024 for those who did NOT purchase the COMBO option at the registration time and which must be paid in advance, in accordance with item 13 of this document.

14. ABOUT THE PUBLICATIONS

The framework of the evaluated and accepted articles for the purpose of publication in Europe by the Editorial Juruá Lda., and in Brazil by *Juruá Ltda* will follow the following criteria:

I. FOR THE JOURNAL "REVISTA INTERNACIONAL CONSINTER DE DIREITO" – QUALIS A3

According to the requirements of national and international agencies of investigation and teaching that evaluate the investigative and academic activity of Post-Graduation, the CONSINTER Executive Coordination, at the best of their judgment, will select a certain amount of articles approved that will be awarded with the Publication in the Journal "Revista Internacional do CONSINTER de Direito" QUALIS A3, with ISSN from Portugal. Also:

- a) For each article selected for the journal "Revista Internacional do CONSINTER de Direito" QUALIS A3, a number of specific and unique register in the DOI (Digital Object Identifier) system will be assigned.
- **b**) A register in the DOI (Digital Object Identifier) system will also be assigned for the journal "Revista Internacional do CONSINTER de Direito" QUALIS A3.
 - c) All articles published in the CONSINTER International Journal of Law QUALIS A3 are available free of charge on the website https://revistaconsinter.com/. Click here and access the CONSINTER Journal.
 - d) In the CONSINTER International Journal of Law, only articles written in coauthorship by a maximum of three (03) authors will be published.
 - e) The CONSINTER International Journal of Law QUALIS A3 is indexed in national and international databases such as: Google Scholar, Scielo Portugal, Latindex, REDIB, CAPES, LivRe, Diadorim, Sumários.org, Cite Factor, Superior Electoral Court, Rede Virtual Integrated Libraries (RVBI), MIAR, MIGUILIM, Dialnet and member of Crossref.
 - f) CONSINTER uses the Open Journal Systems Platform OJS for article submission, which aims to streamline the editorial management process, a tool that assists the editorial process of receiving articles, communicating with authors and automating peer review, and blindly, giving CONSINTER's official works greater credibility within the scientific community.

In view of technical standards, for the purposes of qualifying the journal, only approved articles in which at least one of the authors and/or author has a Doctorate degree may be selected for the CONSINTER International Journal of Law. Duly approved articles that do not meet this requirement will be published in the CONSINTER Book.

This Notice opens the call for submission of scientific articles for possible publication in one of CONSINTER's official works, in subsequent editions, and their oral presentation as long as they are approved.





It is at the discretion of the Organizing Committee to indicate and number the CONSINTER Magazine or Book in which the approved article will be published.

The indication takes into account numerous factors, from the chronological order of the date of receipt to the date of return after making corrections when requested, among other criteria.

The date of publication of the article is not linked to the date of the call notice nor the date of the event and may be published after the event.

II. FOR THE BOOK "LIVRO DO CONSINTER: DIREITO E JUSTICA"

The other articles approved will be awarded with the publication in the book "Livro de *Direito e Justiça do CONSINTER*", generating 03 distinct editions: 02 editions in Brazil (one ebook an another printed – ISBN/Brasil) and 01 international printed edition (ISBN/Portugal).

15. RULES OF WRITING — THE ARTICLES SENT MUST FULFILL THE FOLLOWING CRITERIA:

It is essential that you download the article template here so that you can write your article according to the CONSINTER standard.

- a) Articles must be submitted via upload on the OJS platform https://revistaconsinter.com/index.php/ojs/about/submissions, following the pattern indicated below for naming the article's article file.
- b) Example: ART IDENT Author submission date article title.
- c) Model: ART IDENT Maria Silva 20-01-2024 Tax Aspects...

For the article, it is mandatory the adoption of the European Union's Institutional Writing Code (Umberto Eco/EU norm) standards - see item 16. This system is similar to the ABNT norms; however, the use becomes easier (all tabs are commas) and only highlights in italics, never in bold.

Note: The article must be submitted with the spelling correction and grammatically.

- d) Be original (not published in books, specialized journals, or in the press in general) and present technical—legal property; national and international relevance of the theme approached, wording fluency, grammar correction, and respect to the ethical and scientific aspects.
 - **Note**: The texts inserted in documents of restricted circulation at universities will be considered original.
- e) Have been produced by students and/or professors of *Lato Sensu* and/or *Stricto Sensu* Post Graduation courses, or by Masters, Doctors and Post-Doctors.





- f) Works in co-authorship will be accepted, up to the maximum of 3 participants properly registered, and it is mandatory to indicate the percentage of contribution of each author in the article.
- g) Be identified with one of the criteria of classification to be informed in the public notice, see item 3.
- h) The author (s) that submit the same scientific article (with the same title and content or only having the title changed) for more than one of the fields of Law above mentioned, will have both scientific articles automatically eliminated from the evaluation.
- i) Author identification and affiliation: It must appear just below the title, obligatorily in this order: Name, ORCID, in the format of the example below:

Luiz Antônio¹ - ORCID XXXX-XXXX-XXXX.

- j) The author's qualification and affiliation² must also be included in a footnote:
 - maximum 04 lines.
 - the current degree or the academic training of the authors at the last levels.
 - the name of the Higher Education Institution (college + University, when applicable) to which it is linked, the city, state, country, and ZIP code (Postal code) of the said Institution.
 - the email address of the author(s).
 - the ORCID number (if you don't have one, ask for it https://orcid.org/signin).

Example: Doctoral Student/Doctor/Post-Doctoral Student in Law XXXX by the Faculty of Law XXXX, University XXXXX, city, Country, postal code 1649-014, e-mail xxxxxx@xxxx.com.br, ORCID XXXX-XXXX-XXXXX.

- j) Be submitted in Word format in two distinct files, one with and the other without identification, both complete.
- k) For the file without identification it is important for the author to make sure that, in the article's content to be evaluated, there is no information that makes it possible to identify the author or the Institution they are directly or indirectly bound to.
- 1) The text must comply with the following characteristics: Times New Roman font; body 12; justified alignment, without syllable separation; 1.5 spacing between lines; 1.5 cm paragraph; do not put special spacing before or after each paragraph; 3 cm for top and left margins, 2 cm for bottom and right; on A4 size paper; explanatory footnotes on the same page where the reference is cited and the References must follow the Technical Standards of the European Union Institutional Writing Code (Norma Umberto Eco/EU) see item 17;

Note: The article must contain a minimum of 15 and a maximum of 25 pages, and the pages must be numbered.

m) The text must contain:

• Title in two languages, one of which must be in English.

² Inform the name of the Higher Education institution with which you are linked as a student or as a teacher, if applicable, inform both of them.





- Summary to be indicated following the presentation of the title.
- Abstract (between 100 and 250 words peremptorily with 02 languages), one in Portuguese or Spanish and the other necessarily in English.
- Keywords (between 3 and 10 words) must be indicated in two languages, being an absolute indication in the English language.

Examples:

- If written in Portuguese: The Abstract and the Keywords must be written in Portuguese and English.
- If written in Spanish: The Abstract and the Keywords must be written in Spanish and English.
- If written in English: The Abstract and the Keywords must be written in English and in Portuguese.
- n) The author must indicate both in the abstract and the introduction:
 - **Objective** is a brief description of the study, why it was carried out, and what it proposes.
 - **Hypothesis** Quite directly, the hypothesis in academic work is a statement that seeks to answer the research problem. In other words, it is a statement that can be challenged throughout the research.
 - Methodology used The method describes how the study was carried out, especially
 its most important characteristics (e.g., quantitative, qualitative, or multimethod
 study; description of study participants, instruments, etc.) and data collection and
 analysis procedures.
 - **Results achieved** The results describe the study's main findings, specifically those that respond to the objective of the referred study.
 - **In the final considerations** The final considerations consist of the description of the main contributions brought by the study and indications for future studies.
- o) English articles have priority in analysis and publication, as long as one of the authors has a Ph.D.
- p) For every title, subtitle, all of them aligned on the left, there must be a corresponding text.
- q) The text must be written in a clear and objective way, avoiding long-winded and strenuous paragraphs, giving priority to sentences in the direct order, such as subject-predicate complement.
- r) Texts with figures, illustrations, and/or photographs will not be accepted, except for graphs and tables which are indispensable for the understanding of the work, <u>and compatible with black and white printing</u>, being prohibited the use of graphs and tables if originated from a third party.
- s) Footnotes and bibliographic references: It is mandatory to include the same information in both, as they are carefully verified.

Citations must always be from secure locations, both physical and virtual (see accepted model of the Humberto Eco system in item 16).

Plagiarism or literal copies are not allowed, under penalty of disapproval. The text must be accompanied by the copyright form – according to the model attachment and/or available on the site.





- t) The text must be accompanied by the authorization form for publication assignment of Copyright/Patrimonial Rights according to the attached model and/or available on the website.
- u) All articles must be accompanied by proof of payment for each author and co-author's registration/submission. Proof can be sent to the email contato@consinter.org, indicating the title of the article in the subject of the email.

NOTE: Please note that to present the article orally during the current year's event, interested parties must pay the additional participation/presentation fee available on the CONSINTER website within sixty (60) days before the event.

v) Observing the qualification rules, only one article from each author may be released for publication in the *Revista Internacional CONSINTER de Direito - QUALIS A3*. In case of approval of two or more articles by the same author for the Journal, the evaluation committee, at its best judgment, will choose one for publication in the Journal and the others will be directed for release in the Law and Justice book or in the next issues of the Journal.

- w) An author can insert as many articles as they wish on the OJS platform. However, they must pay the registration/submission fee for each article submitted. Payment must be made by author for each article submitted.
- x) **CONSINTER does not reimburse payments made**, even when the articles have not been approved by the CONSINTER Editorial Board and/or Board of Reviewers.
- y) In view of the technical standards for journal qualification purposes, only approved articles in which at least one of the authors and/or author has a Doctorate degree may be selected for the CONSINTER International Journal of Law QUALIS A3. Duly approved articles that do not meet this requirement will be published in the CONSINTER Book Direito e Justiça.

Note: The indication takes into account numerous factors, from the chronological order of the date of receipt to the date of return after making corrections when requested, among other criteria.

- x) The date of publication of the article is not linked to the date of the call notice nor the date of the event and may be published after the event.
- z) Observing the qualification standards, only one article by each author may be released for publication in the CONSINTER International Journal of Law QUALIS A3. In case of approval of two or more articles by the same author for the Journal, the evaluation committee, in its best judgment, will select one for publication in the Journal, and the others will be sent for publication in the book Direito e Justiça or for publication in the next issues of the Journal.

- Features highlighted with an asterisk are mandatory.

17. ABOUT THE ARTICLE REVIEW

The scientific articles are analyzed by the CONSINTER Editorial Board, formed only by renowned Doctors and Post-Doctors, jurists, Brazilian and foreigners, especially invited. The scientific articles will be evaluated by the double-blind review system, in which two CONSINTER members of the board will evaluate the works without any authorship identification. The assessment of scientific articles by anonymous authors guarantees impartiality of judgment and decreases subjectivity and ideological preferences. This way, authors must avoid direct references to themselves and citations that make it possible to extract its authorship from the reading of the text.

If the scientific article is accepted by one of the CONSINTER members and failed by another, the text, at the suggestion by the Director Council, can be subjected to the assessment by a third party.

- a) The content of the scientific articles is the authors' full responsibility, and after subjected to assessment cannot go through any changes or replacements, except if requested by the Editorial Board.
- **b)** Plagiarism or the insertion of literal copies are not allowed.





18. EVALUATION CRITERIA

The evaluation will follow the following criteria:

- **a)** Compliance with registration/submission rules + payment.
- **b)** Strict compliance with the Rules for writing articles (they must meet the criteria described in item 15 of this document.
- c) Check for plagiarism.
- **d)** Pertinence, timeliness, and originality of the theme chosen.
- e) Depth in the approach of the theme chosen.
- **f**) Appropriate methodology for the development of the theme chosen.
- **g)** Novelty brought by the approach.
- **h)** Wording quality.
- i) Adequacy of the article to the scope of the Journal.
- **j**) Compliance with the rules provided in the Notice.
- **k)** Pertinence of the title to the content proposed by the author.
- **l)** Pertinence of the abstract when describing the aim, theoretical background, methodology, the main results, and conclusions.
- m) Text structure.
- n) Aims.
- o) Theoretical background.
- **p)** Results/ Discussion.
- **q)** Final considerations or conclusion.
- r) Merit.
- s) Significant contribution of the work to knowledge advancement.

Significant contribution of the work to knowledge advancement. Each one of the criteria above indicated will be measured considering the following variables:

- a) Inadequate;
- **b**) Regular;
- c) Good
- d) Excellent;

Regarding the principle of impartiality, the decision by the CONSINTER Editorial Board is sovereign and confidential.
