5. NOTICE FOR ARTICLES

This Notice/Symposium opens the call for scientific articles to be submitted for possible publication in one of *CONSINTER's* official international works, subsequent editions, and oral presentation, provided they are approved.

Papers are accepted in all areas of Law, written in the following 5 languages – Portuguese, Spanish, English, French, and Italian; see item 8 on article classification.

Articles will be evaluated by the *CONSINTER* Board of Reviewers/Editorial Board through the double-anonymized review system; if approved, they will be published in one of *CONSINTER's* official works and may be presented orally during the XI *CONSINTER* Symposium upon payment of the additional fee for participation/presentation of the article at the event, which may be done at the time of registration or up to 60 days before the event, according to the conditions provided in the notice item No. **13. SUBMISSION TERM.**

The publication of scientific articles does not depend on their oral presentation at the event.

7. OPEN JOURNAL SYSTEM – OJS

CONSINTER uses the Open Journal Systems Platform – OJS, a software that aims to streamline the editorial management process and electronic publication of the *CONSINTER International Law Journal – Qualis A3 and the Direito e Justiça* book.

It is a tool that assists the journal's editorial process with sending and receiving articles, communicating with authors, and automating peer and anonymous reviews. 12. INFORMATION ON PUBLICATIONS

Articles will be selected and approved by the *CONSINTER* Editorial Board and/or Board of Reviewers, meeting scientific quality criteria. Analysis will be carried out using the double-anonymized review system, following the requirements of national and international research and teaching agencies and institutions that evaluate Postgraduate research activity.

Texts will be selected by the *CONSINTER* Editorial Board at their discretion for publication in periodic editions of the *CONSINTER* International Law Journal— *Qualis A3* or *Direito e Justiça* book.

If approved for the Journal, it will be published in print and digital versions with their respective Portuguese ISSNs, with the digital version made available free of charge on the link <https://revistaconsinter.com/edicoes-antiores/>. The *Direito e Justiça* book, with an ISBN register, will have three editions: a printed edition in Portugal and two editions in Brazil (one digital and one printed).

The article's selection for publication considers numerous factors, including the chronological order of the receipt date and the return date after making corrections when requested.

The main criterion for publication in the *CONSINTER* International Law Journal is the author or one of the authors having the title of PhD; otherwise, his article will be evaluated anyway, and if approved by the *CONSINTER* Council, it will be published in the *Direito e Justiça* book.

The article's publication date is not linked to the call notice's or the event's and may be published after those.

The Publication of the approved articles by the Editorial Board and/or Referees Board does **not** depend on the presence of the authors in the Symposium.

Approval of the articles will be communicated directly to the author by email.

15. PUBLICATION CONDITIONS

- a) Submission of scientific work for analysis is subject to registration confirmation by payment from all authors and co-authors.
- b) Only articles approved by *CONSINTER's* Body of Reviewers/Editorial Board, which are by the article submission notice, will be published.

16. ORAL PRESENTATION

May be presented at the Symposium of the current year, all articles duly registered:

- In the previous notice of 2024
 - Or in this notice until September 30, 2024.
- a) For oral presentations of articles duly registered, paid, and approved until July 31, 2024, there will be an additional **cost** of BRL 890.00 (eight hundred and ninety Brazilian reais) in case of acquisition of separate participation/presentation (see item 15, letter "g").

- b) In case of acquisition of the **COMBO option (registration/submission + participation/presentation of the article)**, no additional cost will be charged. NOTE: In both cases, the author or co-authors will be able to present it orally during the Symposium of the current year, and it is essential to request and confirm it to the following email: contato@consinter.org
- c) Those who purchased only the submission, if they wish to participate in the current year's event or present their article there, must pay the additional participation/presentation fee available on the *CONSINTER* website within sixty (60) days before the event.
- d) All those who will be present at the event must pay the additional fee, even if they do not present their article, since the participants there will be given certificates of participation in the Symposium issued by the organizing University (by signing the attendance list).
- e) The number of presentations will be limited, and selection will be made based on registration/presence confirmation, which will be at the discretion of the event organization.

18. REGISTRATION

- a) For payment in foreign currency, check trading day.
- b) Check the deadlines for registration and payment and uploading the submission.
- c) It is essential to pay the registration of the authors and co-authors at the time of registration; it will entitle the article to be evaluated.

- d) Co-authored articles will be accepted as long as all authors are duly registered, with a maximum of 03 (three) co-authors per article allowed.

- f) The date of the article's submission depends on the registration date of the author(s). 21. ABOUT THE PUBLICATIONS

The framework of the evaluated and accepted articles for the purpose of publication in Europe by the Editorial Juruá Ltda., and in Brazil by Juruá Ltda, will follow the following criteria:

I. FOR THE JOURNAL *REVISTA INTERNACIONAL CONSINTER DE DIREITO – QUALIS A3*

According to the requirements of national and international agencies of investigation and teaching that evaluate the investigative and academic activity of Post-Graduation, the *CONSINTER* Executive Coordination, at the best of their judgment, will select a certain number of articles approved that will be awarded the Publication in the *Journal Revista Internacional do CONSINTER de Direito*, with ISSN from Portugal. Also:

- a) For each paper selected for the journal *Revista Internacional do CONSINTER de Direito – Qualis A3*, a number of the specific and individual register in the DOI (Digital Object Identifier) system will be assigned.
- b) A register in the DOI (Digital Object Identifier) system will also be assigned to the journal *Revista Internacional do CONSINTER de Direito – Qualis A3*.
- c) All articles published in the “*Revista Internacional do CONSINTER de Direito – Qualis A3*” will be made available, free of charge, on the Editorial Juruá website - <https://revistaconsinter.com/>, click here and access *Revista do CONSINTER*.
- d) The *Revista Internacional CONSINTER de Direito* will only publish articles written in co-authorship with a maximum of three (03) authors.

e) The journal *Revista Internacional CONSINTER de Direito Qualis A3* is indexed on national and international databases, such as *Scielo Portugal, Google Acadêmico, Dialnet, Latindex, Miar, Sumarios.org, MIGUILIM, REDIB, Diadorim, CAPES, LivRe, Cite Factor, Tribunal Superior Eleitoral, Rede Virtual de Bibliotecas Integradas (RVBI) and Member of the Crossref.*

f) *CONSINTER* uses the Open Journal Systems Platform – OJS for article submission, which aims to streamline the editorial management process, a tool that assists the editorial process of receiving articles, communicating with authors, and automating peer and anonymous reviews, giving greater credibility to *CONSINTER's* official works within the scientific community.

In the face of the technical rules, for the journal qualification, only the articles approved in which a least one of the authors and/or author has a doctorate will be selected for the journal *Revista Internacional CONSINTER de Direito – Qualis A3*. The articles duly approved that do not fulfill this requirement will be published in the Book of *CONSINTER Direito e Justiça*.

The Organizing Committee will be in charge of the nomination and the issue of the journal *Revista Internacional CONSINTER de Direito* or of the *CONSINTER* book of *Direito e Justiça* in which the approved article will be authorized for Publication.

The indication considers numerous factors, from the chronological order of the receipt date to the return date after corrections have been made when requested, among other criteria.

The article's publication date is not linked to the call notice's or the event's and may be published after those.

II. FOR THE BOOK OF *CONSINTER: DIREITO E JUSTIÇA*

The other articles approved will be awarded the Publication in the book of *CONSINTER Direito e Justiça*, generating 03 distinct editions: 02 editions in Brazil (one ebook and the other printed - ISBN/Brazil) and 01 international printed edition (ISBN/Portugal).

22. WRITING RULES – ARTICLES SUBMITTED MUST MEET THE FOLLOWING CRITERIA

- Articles that do not comply with the rules below shall be disqualified.

You must download the article template [here](#) to write your article according to the *CONSINTER* standard.

- a) Articles must be uploaded on the OJS Platform:
<https://revistaconsinter.com/index.php/ojs/about/submission>, following the pattern below for naming the article file.

For example: ART IDENT¹ – Author² – submission date³ – article title⁴.

Model: ART IDENT – Maria Silva – 01-20-2024 – Tax Aspects...

ART WITHOUT IDENT – submission date – article title

Model⁵: ART IDENT – 01-20-2024 – Tax Aspects...

- b) For the article, it is mandatory the adoption of the European Union's Institutional Writing Code (Umberto Eco/EU norm) standards - see item 23.

This system is similar to the ABNT norms; however, the use becomes easier (all tabs are commas) and only highlights in italics, never in bold.

NOTE: The article must be submitted with the spelling correction and grammatically.

- c) Be original (not published in books, specialized journals, or in the press in general) and present technical–legal property; national and international relevance of the theme approached, wording fluency, grammar correction, and respect to the ethical and scientific aspects.

Note: The texts inserted in documents of restricted circulation at universities will be considered original.

- d) Have been produced by students and/or professors of *Lato Sensu* and/or *Stricto Sensu* PostGraduation courses, or by Masters, Doctors and Post-Doctors, according to the target audience specified in item 10 above.

- e) Works in co-authorship will be accepted, up to the maximum of 3 participants properly registered, and it is mandatory to indicate the percentage of contribution of each author in the article.

- f) Be identified with one of the criteria of classification to be informed in the public notice, see item 8.

- g) The author (s) that submit the same scientific article (with the same title and content or only having the title changed) for more than one of the fields of Law above mentioned will have both scientific articles automatically eliminated from the evaluation.

- h) Author identification and affiliation: It must appear just below the title, obligatorily in this order: Name, ORCID, in the format of the example below:

¹ ART IDENT – abbreviation for identified article.

² Author – name of the author of the article, stating the first name when there is only one author and, or first and last name when it is a co-authored article.

³ Submission date – upload date information of the article.

⁴ Article title – indication of the article title.

- i) The author's qualification and affiliation must also be included in a footnote:
- maximum of 04 lines.
 - the current degree or the academic training of the authors at the last levels.
 - the name of the Higher Education Institution (college + University, when applicable) to which it is linked, the city, state, country, and ZIP code (Postal code) of the said Institution.
 - the email address of the author(s).
 - the ORCID number (if you don't have one, ask for it at <https://orcid.org/signin>).

Example: Doctoral Student/Doctor/Post-Doctoral Student in Law XXXX by the Faculty of Law XXXX, University XXXXX, city, Country, postal code 1649-014, email xxxxxx@xxxx.com.br, ORCID XXXX-XXXX-XXXX-XXXX.

- j) Be submitted in Word format in two distinct files, one with and the other without identification, both complete, containing a minimum of 15 and a maximum of 25 pages, and the pages must be numbered.
- k) For the file without identification, it is vital that the author assures that the article's content to be evaluated does not contain any information that allows the identification of the author or the Institute to which he is directly or indirectly linked.

The text must have the following characteristics: Times New Roman font; body 12; justified alignment, without syllable separation; 1.5 spacing between lines; 1.5 cm paragraph; do not put special spacing before or after each paragraph; top and left margins with 3 cm, bottom and right with 2 cm; on A4-size paper; explanatory footnotes on the same page where the reference is cited and the

Fictitious name.

The ORCID number must be indicated in full, for example <https://orcid.org/0000-0002-0000-0000>.

- l) References must follow the Technical Standards of the European Union Institutional Writing Code (Uberto Eco/EU Standard) – see item 23.
- m) The text must contain:
- **Title** in two languages, one of which must be in English;
 - **Summary** to be indicated following the presentation of the title;
 - **Abstract** (between 100 and 250 words - peremptorily with 02 languages), one in Portuguese or Spanish and the other necessarily in English;
 - **Keywords** (between 3 and 10 words) must be indicated in two languages, being an absolute indication in the English language. **Examples:**

- If written in Portuguese: the Abstract and the Keywords must be written in Portuguese and English.
 - If written in Spanish: the Abstract and the Keywords must be written in Spanish and English.
 - If written in English: the Abstract and the Keywords must be written in English and in Portuguese.
- n) The author must indicate both in the abstract and the introduction:
- **Objective** - is a brief description of the study, why it was carried out, and what it proposes.
 - **Hypothesis** - Quite directly, the hypothesis of the academic work is a statement that seeks to answer the research problem. In other words, it's a claim that can be challenged throughout research.
 - **Methodology used** - The method describes how the study was carried out, especially its most important characteristics (e.g., quantitative, qualitative, or multimethod study; description of study participants, instruments, etc.) and data collection and analysis procedures.
 - **Results achieved** - The results describe the study's main findings, specifically those that respond to the objective of the referred study.
 - **In the final considerations** - The final considerations consist of the description of the main contributions brought by the study and indications for future studies.
- o) English articles have priority in analysis and publication as long as one of the authors has a Ph.D.
- p) For every title, and subtitle, all of them aligned on the left, there must be a corresponding text.
- q) The text must be written in a clear and objective way, avoiding long-winded and strenuous paragraphs, giving priority to sentences in direct order, such as subjectpredicate-complement.
- r) Texts with figures, illustrations, and/or photographs will not be accepted, except for graphs and tables, which are indispensable for the understanding of the work **and compatible with black and white printing**, being prohibited the use of graphs and tables if originated from a third party.

NOTE: The printing system used by CONSINTER to print approved articles is in black and white (gray scales). Therefore, colored graphics must use another information differentiation system other than color, such as icons, dashed lines, and polka dots.

- s) Footnotes and bibliographic references: It is mandatory to include the same information in both, as they are carefully verified.

OBS. Citations must always be from secure locations, both physical and virtual (see the accepted model of the Umberto Eco's system in item 23).

PLAGIARISM OR LITERAL COPIES ARE NOT allowed, under penalty of disapproval.

- t) The text must be accompanied by the authorization term for publication – assignment of Copyright/Patrimonial Rights – according to the attached model and/or available on the website

- u) All articles must be accompanied by proof of payment for the registration/submission of each author and co-author. The proof can be sent to the email contato@consinter.org, indicating the title of the article in the subject of the email.

NOTE: Observing that to present the article orally during the current year's event, interested parties must pay the presentation fee available on the *CONSINTER* website within sixty (60) days before the event.

- v) Noting that *CONSINTER* is a non-profit institution, the value of the registration/submission subsidizes the publication of articles in the *Revista Internacional CONSINTER de Direito – Qualis A3*. The submission/registration fee is individual and exclusive for each author. Therefore, each author must register and pay his/her respective fee.

Ex: For the inclusion of an article in co-authorship with the two authors – it is necessary the registration and payment of the fee for each one of the authors.

- w) An author can insert as many articles as they wish on the OJS platform. However, they must pay the registration/submission fee for each article submitted. Payment must be made by the author for each article submitted.

- x) **CONSINTER DOES NOT REFUND PAYMENTS MADE**, even when the articles have not been approved by the *CONSINTER* Editorial Board and/or Board of Reviewers

- y) In view of the technical norms for journal qualification purposes, **only approved articles in which at least one of the authors and/or author has a PhD degree can be selected for the International Journal of Law – Qualis A3**. Duly approved articles that do not meet this requirement will be published in the *CONSINTER* Law and Justice Book.

NOTE: The indication of the work in which the article will be published takes into account numerous factors, from the chronological order of the date of receipt to the date of return after making corrections when requested, among other criteria.

The article's publication date is not linked to the call notice's date, nor to the event's, and may be published after those.

- **ATTENTION TO THE NEW SYSTEM ADOPTED**

For indicating the sources of the citations, the articles must adopt the European Union's Institutional Drafting Code standards (Umberto Eco/EU norm).

General rules:

- All elements must be separated only by a comma.
- Features highlighted with an asterisk are mandatory.

1. Book

- 1) * LAST NAME (in small caps) and Author's First Name (s),
- 2) * *Title and subtitle of the book* (in italics), 3) («Collection»),
- 4) * Edition number if there are several,
- 5) * Location, 6) * Publisher, 7) * Year.
- 8) Possible data from the most recent edition.
- 9) Number of pages and the potential number of volumes of which the work is composed.
- 10) * Translation.

24. ABOUT THE ARTICLE REVIEW

The *CONSINTER* Editorial Board analyzes the scientific articles, formed only by renowned Doctors and Post-Doctors, jurists, Brazilian, and foreigners, especially invited.

The scientific papers will be evaluated by the double-blind review system, in which two *CONSINTER* members of the board will determine the works without any authorship identification. The assessment of scientific articles by anonymous authors guarantees the impartiality of judgment and decreases subjectivity and ideological preferences. This way, authors must avoid direct references to themselves and citations that make it possible to extract its authorship from the reading of the text.

If the scientific article is accepted by one of the *CONSINTER* members and failed by another, the text, at the Director Council suggestion, can be subjected to a third-party assessment.

- a) The content of the scientific articles is the authors' full responsibility, and after subjected to assessment, cannot go through any changes or replacements, except if requested by the Editorial Board;
- b) Plagiarism or the insertion of verbatim copies are not allowed.

25. EVALUATION CRITERIA

The evaluation will follow the following criteria:

- a) Compliance with registration/submission rules + payment.
- b) Strict compliance with the Rules for writing articles (they must meet the criteria described in item 07 of this document).
- c) Check for plagiarism.
- d) Pertinence, timeliness, and originality of the theme chosen.
- e) Depth in the approach of the theme chosen.
- f) Appropriate methodology for the development of the theme chosen.
- g) Novelty brought by the approach.
- h) Wording quality;
- i) Adequacy to norms foreseen in the notice.
- j) Adequacy of the article to the Journal scope.
- k) Pertinence of the title to the content proposed by the author.
- l) Pertinence of the abstract when describing the aim, theoretical background, methodology, the main results, and conclusions.
- m) Text structure.
- n) Aims.
- o) Theoretical background.
- p) Results/ Discussion.
- q) Final considerations or conclusion.
- r) Merit.
- s) Significant contribution of the work to knowledge advancement.

Each one of the criteria above indicated will be measured considering the following variables:

- a) Inadequate.
- b) Regular.
- c) Good.
- d) Excellent.

Regarding the principle of impartiality, the decision by the *CONSINTER* Editorial Board is sovereign and confidential.
